Located approximately 8 miles northeast of Scottsbluff, Nebraska, this farm is in the Little Lake Alice area. The Staman Irrigated Farm has many access points including two county roads and a canal road. The farm features a four-tower pivot which irrigates 54± acres and two side fields that are gravity irrigated. The remaining acres include 5± acres of trees, 21± acres of dry ground and an old homesite. The Staman Farm has 103± acres of water rights from the Pathfinder Irrigation District and is permitted 40.3± acres of water from the irrigation well. This farm is dual apportioned for water. The Staman Irrigated Farm is currently being leased for 2021. The improvements on the property included a non-livable home and other outbuildings that are in need repairs. This part of Nebraska is known for its excellent farming opportunities as well as outstanding wildlife habitat. Whitetail deer and upland game birds frequent the Staman Irrigated Farm.
